Club Whisper Confidentiality, Consent & Conduct Agreement

This Agreement is entered into by and between Club Whisper ("Organization") and the undersigned participant ("Participant") as a condition of attendance at any Club Whisper event.

PURPOSE

Club Whisper is committed to creating a welcoming, inclusive, respectful, and private environment for all participants. By attending a Club Whisper event, Participant agrees to uphold the principles of consent, confidentiality, personal responsibility, and respectful conduct.

CONFIDENTIALITY AND PRIVACY

Participant acknowledges that privacy is essential to the Club Whisper community and agrees to maintain the confidentiality of all attendees.

- Names, identities, occupations, and personal information
- Relationship status or lifestyle participation
- Social media profiles or online identities

- Conversations and interactions occurring during the event
- Photographs, videos, recordings, or images
- Any information that could reasonably identify another participant

Participant agrees not to disclose, share, publish, post, distribute, or reveal confidential information without consent.

PHOTOGRAPHY AND RECORDING POLICY

No photographs, videos, audio recordings, livestreams, screenshots, or similar media may be taken or shared without the explicit consent of all individuals involved.

CONSENT POLICY

- Consent must be freely given, informed, enthusiastic, and ongoing.
- Silence, intoxication, prior interactions, relationship status, or lack of resistance do not constitute consent.
- Consent may be withdrawn at any time.
- "No" means no. "Maybe" means no. "I'm not sure" means no.
- Only an enthusiastic and voluntary "yes" constitutes consent.

RESPECT AND CONDUCT EXPECTATIONS

- Treat others with dignity, kindness, and respect.
- Honor personal boundaries.
- Communicate openly and honestly.
- Respect diversity and inclusion.
- Contribute to a safe and welcoming environment.

ALCOHOL AND PERSONAL RESPONSIBILITY

Strictly prohibited:

- Harassment or intimidation
- Unwanted touching or physical contact
- Coercion, manipulation, or pressure
- Discrimination
- Aggressive, threatening, or disruptive behavior
- Sharing another participant's personal information without permission

REPORTING CONCERNS

Participants are encouraged to report any concerns regarding consent, conduct, safety, or privacy.

REMOVAL FROM EVENT

Club Whisper reserves the right to remove any participant from an event without refund.

RELEASE OF LIABILITY

Participant voluntarily assumes all risks associated with attending the event.
